1. Assessing Local Corporate Power and Bargaining for the Common Good in Philly (West Room)

We'll look at how power mapping and being aware of the larger power structure can help us fight back. We'll also look at how unions can use bargaining for the common good in contract negotiations to win structural changes they want to see in their communities and shift the power structure.
